Q1: Why is the name change being done now, before completing the Regularisation Plan? What's the rationale behind this?

Response/Answer

A1: We deliberately timed the name change to coincide with the final stages of our Proposed Regularisation Plan so that our rebranding and restructuring efforts reinforce one another and mark a singular, visible fresh start. By launching the Vantris Energy identity now, we ensure that, upon Restructuring Effective Date, we emerge not only financially stronger, but also with a clear, distinct brand that reflects our renewed strategy and bolsters stakeholder confidence from day one.

Q1: Merge all in one to new company. Sapura Global Berhad
Suggestion: Focus on incurring income such like e.g. Toll Road concession operator and In

Response/Answer

A1: Maintaining three focused segments - Engineering & Construction (E&C), Drilling, and Operations & Maintenance (O&M) provides strategic focus, operational discipline, and flexibility that would be lost in a single-entity model.

Each segment faces different market conditions, technical demands, and client needs. By keeping them separate, we can deploy the right assets for the right jobs, optimise utilisation, and drive performance, without one business line draining attention or resources from another. For example, Sapura 3500 and Sapura 1200 are deployed based on segment-specific strategies.

Clear Lifecycle Accountability

We support the full offshore project lifecycle. Keeping segments distinct ensures focused investment and accountability at each stage - from construction to drilling to long-term maintenance while still enabling us to deliver integrated solutions when needed.

Response/Answer

A2: Vantris was proposed by one of our employees during a company-wide naming exercise. It was chosen because it's distinct, easy to remember, and reflects the direction we're heading.

The name blends "Van" from vanguard, which stands for leadership and moving forward, and "tris," representing the number three - a reference to our three business segments, three values, and three guiding principles.

Engku Muhammad Faiz Bin Engku Abdul Rahman posted the following question:

Q3: What will be the cost for the entire rebranding given the change in name, including all our assets. How is it going to be funded.

Response/Answer

A3: The total cost of the rebranding is budgeted at RM10 million, funded through our existing operating expenditure. This includes legal filings, marketing, system updates, signage changes, and operational costs like repainting vessels and refreshing digital platforms.

It's a significant reduction compared to the RM23 million spent on our last brand refresh in 2018. We've kept it lean by working with local partners, doing more internally, and rolling it out in phases - prioritising critical business areas first. Where possible, asset changes like vessel repainting will align with scheduled maintenance to manage costs.

The rebrand is part of repositioning the company, but it's being done with financial discipline in mind - to support recovery, not burden it.

Q4: How does this Change of name benefits the company and shareholders. How much does the company Spend on this Change name exercise

# Response/Answer

A4: The change to Vantris Energy marks a new chapter in our transformation journey. It reflects the progress we've made in strengthening our fundamentals, restoring credibility, and repositioning the company for long-term growth. A refreshed identity allows us to better align with our future direction - as a trusted, solutions-focused energy partner, while signalling a clear break from the past.

For shareholders, this rebrand supports a more focused and future-ready company. It helps clarify who we are, improves our market visibility, and reinforces the momentum we've built through restructuring.

This exercise was carried out with prudent cost discipline. Most components were developed internally - including the name, which was selected from employee submissions, and the visual identity, designed by our Strategic Communications team. We've budgeted RM10 million for the full rebranding exercise, which covers legal filings, system updates, signage changes, onboard brand repainting on vessels, and digital touchpoint refreshes.

This is significantly lower than our last brand refresh in 2018, which cost approximately RM23 million. The rollout is being phased and tightly managed with asset updates aligned to maintenance cycles wherever possible - to ensure the rebrand supports recovery without adding financial pressure.
